Breathing Protection

The American Lung Association says it best: "When you can't breathe, nothing else matters!" Breathing protection is necessary on many construction sites. In some cases a simple dust mask may be adequate. In others, a self-contained air supply may be needed. Make sure that a proper hazard evaluation is done **before** any employees are exposed to a potentially harmful atmosphere.

If respirators are being used, cleanliness and fit are extremely important. A little facial hair can break the seal between the respirator and the face and make the respirator useless. An employee could die "by the hair on his chinny chin chin!"

Hearing & Head Protection

Hearing Protection: Whenever possible, administrative and engineering controls should be used to reduce noise exposure. When those options are not feasible or not sufficient, personal hearing protection is a must. Make sure that the Noise Reduction Rating (NRR) of the hearing protection will sufficiently reduce the noise level at the ear. Proper fit of hearing protection is an absolute necessity for proper protection.

Head Protection: Hard hats are designed to protect against bumps, falling objects, and electrocution. There are two types and three classes of hard hats. Make sure that each of your employees is wearing a hard hat that will provide the protection needed for his or her job.

Hand & Foot Protection

While most hand and foot injuries are not fatal, they are painful and can be permanently disabling. Many finger, hand, and foot amputations are caused by powerful tools and equipment (saws, presses, forklifts, etc.) and cannot be prevented by PPE. Remind all employees of potential amputation hazards. When they are using saws, train them to not hold the workpiece being cut with their hands.
