## Training & Documentation

The federal Occupational Safety and Health Administration requires that employees who use or handle hazardous material be properly trained. If hazardous materials are used on your site, proper training is your first line of defense against accidents and injuries and the costs that follow. Beyond training the employees who will use the chemicals, make sure that other employees are explicitly aware that they are **not allowed** to use those chemicals. For more information see the Subpart Z starting at 29 CFR 1910.1000.

No one plans chemical emergencies, but you should always plan **for** them. Once an emergency has occurred, it's far too late to establish a plan.
